CD Submission Guidelines

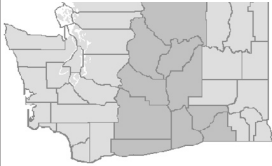
- Artwork will be juried from digital photo files submitted on your CD
 - Actual work must be identical to image
 - Digital images must be cropped to the artwork itself. Do not include the frame or mounting in the digital image
 - The longer side of the digital image, width or height, must be 7in. If the image is a square it will be 7in x 7in
 - The digital image must be saved as a 150 pixel-per-inch (ppi) file in the JPEG (jpg) format
 - Each file size must be smaller than 1 Megabyte (MB)
 - Label your CD with a permanent marker with your complete name and phone number
 - Your CD will not be returned.
 - Test your CD before submitting. Applicants will not be contacted if their CDs are not readable by our Mac system
 - For each artwork include 1 overall image and up to 2 detail images. For 3D artwork, submit 1 overall image and up to 4 detail images
 - Files must be named: "A,B,or C-last name of artist_title of work.jpg". ie. "A-Smith_Morning Walk.jpg", with the letters matching registration form
 - Detail images should be labeled "A,B, or C-last name_detail 1 or 2". ie. "A-Smith_detail 1.jpg".
 - SETS: Artwork of multiple units are considered one submission only when priced and labeled as one piece. Sets must include 1 image of the overall set and 1 image of each part labeled with the letter and number (A-1, A-2, A-3)
- Actual Size of Accepted Work:**
- 2D: artwork cannot exceed 80" in any direction
 3D: artwork cannot exceed 8 square feet of floor space, 8 ft in height, or weigh over 200lbs.

About the Juror

Isaac Layman's photographs offer hyper-real, psychologically charged visions of the spaces and objects found in his Seattle home. His work has garnered increasing attention across the United States and earned reviews in leading journals including Art Papers, Artweek, and Art in America as well as National Public Radio. His works are included in the collections of the Seattle Art Museum, Tacoma Art Museum, Henry Art Gallery University of Washington, Houston Museum of Fine Art, and the Norton Art Museum as well as numerous private collections including the Margulies collection. Mr. Layman was the Betty Bowen Award recipient in 2008 and is serving on the award committee for 2009-2011.

Open to all Central Washington artists. Only original work designed and executed by the exhibiting artist in the past three years is eligible for entry. No more than three entries per artist. Pieces previously exhibited in Peggy Lewis Gallery (formerly the Allied Arts Gallery) will not be accepted, excluding pieces in the Art Boutique and Art of Giving.

MEDIA

Sculpture, photography, drawing, jewelry, pottery, prints, fiber arts, painting, and mixed media.

CONDITIONS

The Peggy Lewis Gallery reserves the right to refuse to accept any entry if, in its opinion, it is too fragile, oversized, or does not meet conditions of eligibility. Neither the Gallery nor Allied Arts can assume responsibility for loss or damage during shipment. Allied Arts cannot cover art shipment costs either to or from the gallery. Insurance coverage will be arranged for accepted art pieces.
